A.        The Applicant’s Motion/Position Statement is due by January 6, 2017, and the Protestants and Staff’s Response is due January 27, 2017.

B.        The Parties have 15 days from the date of service of this Order plus 3 days if service is by mail to petition for reconsideration.<sup>1</sup>
