ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On November 22, 2017, Streamline Energy, LLC (Applicant) filed an Application to dispose of saltwater into the Arbuckle Formation at the Rains #SWD well in Montgomery County, Kansas.¹
2. On December 20, 2017, Adell T. Nellis filed a protest² and on January 4, 2018, requested a hearing.³
3. On February 15, 2018, the Commission issued its *Order Designating Prehearing Officer and Setting Prehearing Conference* (Order), which designated Samuel Feather as the Prehearing Officer in this proceeding.⁴

4. On April 26, 2018, Michael J. Duenes was designated as the new Prehearing Officer.⁵

5. On August 28, 2018, the Protestant, Ms. Nellis, submitted a letter to Commission Conservation Staff (Staff), stating she had reached an agreement with the Operator in this matter, and therefore, was withdrawing her protest.⁶

6. On August 31, 2018, Staff filed a Motion to Close Docket, stating that the Protestant's withdrawal of her protest renders the Operator's Application uncontested, and therefore, Staff may act on the Application without a Commission order.⁷ Staff requested the Commission close the docket and allow Staff to process the Application administratively.⁸

7. In light of the Protestant's withdrawal of her protest and Staff's Motion to Close Docket, the Commission finds further proceedings are unnecessary, Staff shall process the Operator's Application administratively, and this docket shall be closed.

THEREFORE, THE COMMISSION ORDERS:

A. Staff is directed to process the Operator's Application administratively, and this docket is closed.

B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁹

C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.


