ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds as follows:

1. On February 7, 2018, SEK Energy, LLC (Operator) filed Applications for an exception to the 10-year time limitation of K.A.R. 82-3-111 in the above-captioned dockets.

2. On April 30, 2018, Commission Conservation Staff (Staff) filed a Motion for Consolidation of Dockets, the Designation of a Prehearing Officer, and the Scheduling of a Prehearing Conference in the seven individual dockets.

3. On May 17, 2018, the Commission issued its *Order Consolidating Dockets, Designating Prehearing Officer, and Setting Prehearing Conference*, scheduling a Prehearing Conference for June 7, 2018.¹ The Prehearing Conference was subsequently continued to July 12, 2018.²

4. On August 20, 2018, the Operator filed a letter stating that “SEK Energy, LLC is withdrawing it’s [sic] request for any further hearings and requests for Docket No: 18-CONS-3313-CEXC to be closed immediately.”³

5. On August 28, 2018, Staff filed a Motion to Close Docket, stating that because “the Applications in the above captioned dockets have been withdrawn, Staff recommends the consolidated dockets should be closed, as further proceedings are unnecessary.”⁴

6. In light of the Operator’s letter withdrawing its request for further hearings and Staff’s Motion to Close Docket, the Commission finds further proceedings are unnecessary, and this docket should be closed.

THEREFORE, THE COMMISSION ORDERS:

A. This docket is closed.


B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁵
