**ORDER DESIGNATING NEW PREHEARING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On February 23, 2018, Marshall Oil LLC (Operator) filed an Application seeking authorization for injection of saltwater into the Douglas Formation at the Teter-Spencer No. 2A well located in Greenwood County, Kansas.<sup>1</sup>

2. On June 28, 2018, Dustin Kirk was designated the Prehearing Officer in this proceeding.<sup>2</sup> Mr. Kirk is no longer with the Commission.

3. The Commission designates Michael J. Duenes, Assistant General Counsel, 1500 SW Arrowhead Road, Topeka, Kansas 66604-4027, telephone number (785) 271-3181, [m.duenes@kcc.ks.gov](mailto:m.duenes@kcc.ks.gov), to serve as the new Prehearing Officer.<sup>3</sup> The Prehearing Officer may conduct Prehearing Conferences necessary to address any appropriate matters, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other Staff members to serve in this capacity.
