ORDER DESIGNATING PREHEARING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, and being fully advised in the premises, the Commission makes the following findings:

1. On May 1, 2018, Kansas City Power & Light Company (KCP&L) filed an Application with supporting documents and testimony requesting authorization from the Commission to make certain changes in its charges for electric services in Kansas and for approval of other requests set forth in the Application.¹

2. The Commission designates Michael J. Duenes, Assistant General Counsel, 1500 SW Arrowhead Road, Topeka, KS 66604-4027, telephone number (785) 271-3181, m.duenes@kcc.ks.gov, as Prehearing Officer in this proceeding.² The prehearing officer may conduct any Prehearing Conferences necessary to address any matters appropriately considered in a Prehearing Conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA). The Commission may designate other staff members to serve in this capacity.

3. Although a Prehearing Officer is designated in this docket, parties are still required to file pleadings with the Commission, and filings shall be made with the Commission's Docket Room before 5:00 p.m. on the date scheduled for service. Any electronic service received after the deadline set forth in the procedural schedule, or any filing made after 5:00 p.m. on the date scheduled for service, shall be accompanied by a Motion to File Out-of-Time.

THEREFORE, THE COMMISSION ORDERS:

- A. Michael J. Duenes is designated as Prehearing Officer.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).³
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
