ORDER GRANTING WITHDRAWAL AND CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1. On August 29, 2018, MWK Petroleum Company (Operator) filed an Application for authority to inject water for repressuring of the Cameron #2 well, located in Butler County, Kansas.¹
2. On September 19, 2018, John Pike of Withers, Gough, Pike & Pfaff, LLC, filed an Entry of Appearance as counsel on behalf of Stone Family Farms, LLC. Counsel also filed a Protest of Application on behalf of Stelbar Oil Corporation, Inc. and Stone Family Farms, LLC.²
3. On September 27, 2018, a letter dated September 25, 2018 was filed by the Operator, Michael Kiser, stating he wished to withdraw the pending “application for an injection well for the Cameron #2 Sec. 02-25S-05E in Butler County, Kansas.”³
4. There are no objections to the withdrawal of the application.

C. The Commission retains jurisdiction over the subject matter and the parties and may enter additional orders as it deems appropriate.
