- 1. - 3. On August 2, 2013, Grain Belt Express discovered that an incorrect email address had been used for PACP and, therefore, the comments being filed through the website were not being directed to the PACP office. Grain Belt Express has since corrected the error and any comments received after August 2, 2013 via the website are being directed to the correct email address for PACP.
- 4. During the time leading up to August 2, 2013, Grain Belt Express received notification from the website that 63 comments were made via the website that were not properly directed to the PACP.

WHEREFORE, Grain Belt Express hereby submits the 63 comments received via its website that, due to an error in an email address, did not initially get directed to PACP.
