**PREHEARING OFFICER ORDER GRANTING MOTION FOR 7-DAY  
EXTENSION TO STAFF'S DIRECT TESTIMONY DEADLINE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, the Prehearing Officer makes the following findings:

1. On June 19, 2017, Commission Litigation Staff (Staff) filed a Notice of Denial of License Renewal Application to Western Frontier Adventure, LLC (Operator), stating the license application was denied pursuant to K.S.A. 55-155(c)(4).<sup>1</sup>
2. The Prehearing Officer Order Setting Procedural Schedule dated October 23, 2017, set a deadline for Staff's Direct Testimony to be filed on December 11, 2017. On December 11, 2017, Staff filed a Motion for 7-Day Extension to Staff's Direct Testimony Deadline, requesting until December 19, 2017 to file its pre-filed testimony or resolution of the docket. Staff stated that the Operator did not object to the extension.
3. Therefore, for good cause shown, the Prehearing Officer grants Staff's Motion.
