**MOTION TO CANCEL PROCEDURAL SCHEDULE AND CLOSE DOCKET**


The Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission,” respectively) files this *Motion to Cancel Procedural Schedule and Close Docket*.

In support of its Motion, Staff states as follows:

1. On June 12, 2017, Black-Travis, Inc. (Operator) submitted a license application.
2. On June 19, 2017, Commission Staff denied Operator’s license application because of Operator’s association with Klondike Investments, Inc., License #4665, which is not in good standing with the Commission.
3. On July 5, 2017, Operator timely requested a hearing.
4. On August 25, 2017, the Commission issued an Order Designating Prehearing Officer and Setting Prehearing Conference. The matter was eventually scheduled for a May 15, 2018, evidentiary hearing, with Staff’s pre-filed testimony due February 23, 2018.
5. Pursuant to K.A.R. 82-3-120(h) and Commission policy, Staff has approved Operator’s application and has issued Operator’s license.

WHEREFORE, as no issues remain to be resolved, Staff moves for the procedural schedule to be cancelled and this docket to be closed.



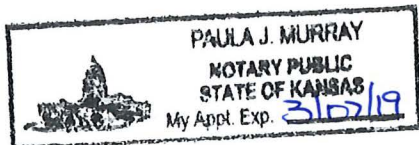
