PRE-FILED REBUTTAL TESTIMONY OF WRAY VALENTINE ON BEHALF OF QUAIL OIL & GAS, LC

- 1 Q. Please state your name, position, employer and office address.
- 2 A. My name is Wray Valentine. I am the Manager of Quail Oil & Gas, LC with a business
- address of P.O. Box K, Garden City, Kansas 67846.
- 4 Q. Do you have any response to the Testimony of Cindy Hoedel?
- 5 A. Yes.
- 6 Q. What are the potential effects of the disposal well on tourism in the Flint Hills?
- 7 A. The use of a disposal well would reduce the amount of truck traffic, noise and dust as
- 8 compared to having to use trucks to haul salt water from the wells that produce oil and gas
- 9 to another disposal site.
- 10 Q. Are there other benefits from using a disposal well?
- 11 A. The use of a disposal well also would serve to prevent waste of oil and gas resources by
- allowing for more economic production than hauling salt water by truck. In turn, more
- economic production would extend the life of the oil and gas wells served by the disposal
- well and thereby provide more royalty income to mineral owners in the Flint Hills, which

- income would have a positive impact on the local community.
- 2 Q. Do you have a response to Cindy Hoedel's comments on earthquake insurance?
- 3 A. As a petroleum engineer and oil man, Ms. Hoedel's comments on insurance are not
- 4 relevant to a determination of whether the Commission should grant the permit to inject
- salt water under K.A.R. 82-3-200 (prevent waste and protect correlative rights) and K.A.R.
- 6 82-3-400 (permitting factors).
- 7 Q. Does this conclude your rebuttal testimony?
- 8 A. Yes.
