Dear Ms. Retz:

On September 13, 2018, Kansas Corporation Commission (KCC or Commission) issued an Order adopting GVNW Consulting, Inc.'s (GVNW) Audit Report and directing Ionex Communications, Inc. (Ionex or Company) to pay a \$1,700 penalty for reporting violations within 30-days from the date of the Order.¹ The Commission also directed GVNW to file an updated Audit Report to remove the previously designated confidential sections within 10-days of the issues of the Order; and within 60-days of the issuance of Order, file a Compliance Report.

GVNW, on September 14, 2018, filed the updated Audit Report. On October 17, 2018, Ionex paid \$1,700 to the Commission's Fiscal Office, 2 days after the ordered due date. Due to the Ionex's violation of the Order, GVNW recommends that the Commission's Staff address Company's failure to remit the \$1,700 penalty by the ordered date.

Therefore, GVNW recommends that the Commission determine Ionex is in compliance with the Commission's Order and that Docket No. 18-ICIT-041-KSF be closed.
