2. On August 7, 2017, the Operator filed a Motion for Summary Judgment and Memorandum in Support.

3. On November 16, 2017, the Commission issued its Order Setting Procedural Schedule, setting deadlines for pre-filed testimony and scheduling an evidentiary hearing for February 15, 2018.<sup>1</sup>

4. On December 8, 2017, Staff filed its Response to Operator's Motion for Summary Judgment (Staff's Response).

5. On December 22, 2017, the Operator filed a Reply to Staff's Response (Operator's Reply).
