TO SURRENDER CERTIFICATE OF CONVENIENCE
TO PROVIDE INTEREXCHANGE TELECOMMUNICATIONS SERVICES

Twin Valley Telephone Company, Inc. (Twin Valley), by and through its attorney Mark Doty respectfully requests the Commission approve the following application to surrender its Certificate of Convenience to Provide interexchange telecommunications services within the state of Kansas. In support Southern Kansas states:

1. Twin Valley, organized in 1957, is a wholly owned subsidiary of Twin Valley Management, Inc. and presently in good standing under the laws of the State of Kansas. It holds a certificate from this Commission to provide intrastate interexchange telecommunications (“IXC”) services in Kansas granted in Docket No. 99-TWVC- 755-COC.


2. In order to streamline operations all Twin Valley long distance customers are being transferred to Twin Valley Communications, Inc., a wholly owned subsidiary of Twin Valley Management, Inc., which possesses a certificate of convenience and

authority to provide interexchange service within the state of Kansas. The effective date of the transfer is September 1, 2025. FCC approval was obtained September 24, 2025.

3. As a result of the transfer existing Twin Valley customers will incur no interruption of service, no changes in rates or any charges associated with the carrier change. Notice of the transfer was provided to Twin Valley customers on or about July 21, 2025 and a copy of the notice is attached to this application. Twin Valley Communications, Inc. is a well established and experienced provider and will continue to provide quality service to Twin Valley customers.

WHEREFORE the Applicant respectfully request expedited Commission consideration of its Application and foregoing information and issue an order cancelling the Certificate of Convenience and Authority of Twin Valley Telephone Company, Inc. to provide intrastate interexchange telecommunications services. Applicant does not seek surrender or modification of any other Certificates of Convenience it holds.


