2. Parties should note the following:
 - a. Failure to submit pre-filed testimony will likely result in the Commission restricting the right to testify and present evidence at hearing.
 - b. At hearing, the Commission may limit direct and rebuttal testimony to the pre-filed testimony.
 - c. Any settlement agreement that the parties wish to present for the Commission's consideration shall be due by February 8, 2015.


- d. Any person requiring special accommodations under the Americans with Disabilities Act is asked to give notice to the Commission at least 10 days prior to the scheduled hearing date.
