On behalf of Pioneer Electric Company ("Pioneer") and City of Hugoton Municipal ("Hugoton"), please find enclosed the following applications for filing:

Application to Cease Operation of Pioneer for service territory located in Stevens County, Kansas:

1. The N/2 of the NE/4 of Section 10, T33S, R37W, starting in the NW/4 corner of the NE/4 of section 10, parallel with the North section line. A strip of land measuring East a distance of 770 feet, thence South a distance of 790 feet, thence West a distance of 770 feet, thence North a distance of 790 feet, to beginning point. In the NE/4 of section 10 T33S-R37W, in Stevens County KS.

Application for Certificate of Pioneer Electric for territory located in Stevens County, Kansas:

1. The S/2 of the SE/4 of Section 15, T33S, R37W, going North parallel with the East section line, less County Right-Of-Way, a distance 775 feet. To a starting point *in* the SE/4 of section 10, excluding as specified, a strip of land measuring West 900 feet, thence North a distance of 90 feet, thence East a distance of 900 feet, thence South a distance of 90 feet to beginning point, *in* the SE/4 of section 15-T33S-R37W, *in* Stevens County KS.

The subject service territory as depicted in attached Exhibit A to each of the Applications to Cease Operation and outlined in red, is located in either a rural area and currently impacts no existing retail customers of either utility. The subject service territory depicted in attached Exhibit B to each of the Applications for Certificate outlined in red is territory and a customer that the City of Hugoton is unable to provide service to because of capacity restraints and infrastructure upgrade costs. Pioneer is capable and willing to provide service to existing customer so that customer is able to continue operations without enduring timely setbacks and extraordinary costs.

Therefore, the Hugoton City Council and Pioneer Electric Board respectfully request with the filings of these Applications that the Commission approve the proposed territory exchanges in order to economically serve this retail consumer.

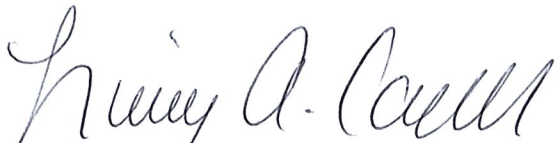
