**JOINT MOTION FOR APPROVAL OF  
STIPULATED SETTLEMENT AGREEMENT**

The Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively) by and through its counsel Ahsan A. Latif, and American Alliance LLC (Respondent), file this Joint Motion requesting the Commission issue an Order approving the attached Stipulated Settlement Agreement. In support of this Motion, Staff and Respondent state as follows:

1. On March 12, 2019, the Kansas Highway Patrol issued a Notice of Violation(s) against Respondent, for alleged violations found during a July 23, 2019, routine motor carrier stop and inspection conducted by the Kansas Highway Patrol (KHP).

2. As a result of this inspection, Respondent was assessed \$900 in civil fines, comprised of the following violation: a \$300.00 fine for Failure to register and pay UCR fees, citing 392.2UCR; a \$150.00 fine for No/improper heavy vehicle/machine securement, citing 393.130; a \$150.00 fine for No/improper breakaway or emergency braking, citing 393.43; a \$150.00 fine for Inoperative turn signal, citing 393.9TS; a \$150.00 fine for Operating a CMV with improper CDL group, citing 383.91A.

3. On August 20, 2019, Hooshang Pour, Owner & General Manager of American Alliance LLC and Mike Hoeme, Transportation Director of Staff, informally discussed the

possibility of a settlement. During this discussion, Staff and Respondent were able to reach mutually agreeable terms in anticipated settlement of the issues. It was agreed that Staff would subsequently reduce the terms to writing and forward the draft to Respondent for approval and signature.

4. The resulting signed Stipulated Settlement Agreement is attached hereto as Attachment "A" and is hereby incorporated by reference. This Agreement resolves all issues in this proceeding between Staff and Respondent. The parties believe that the Agreement represents a reasonable and fair resolution of this matter and that the Commission should approve the Agreement in full.

5. Should the Commission accept the terms of the attached Stipulated Settlement Agreement, the parties waive their respective rights to cross-examine witnesses and present oral arguments or written briefs to the Commission. The parties also waive their rights to request reconsideration of the Commission Order approving the Agreement and waive their rights to seek judicial review of said Order.

**WHEREFORE**, for the reasons set forth herein, Staff and American Alliance LLC request this Joint Motion be granted, and that the attached Stipulated Settlement Agreement be approved.

**STIPULATED SETTLEMENT AGREEMENT**

This Stipulated Settlement Agreement (Agreement) is entered into by and between the Staff of the State Corporation Commission of the State of Kansas (Staff and Commission, respectively), and American Alliance LLC (Respondent). Its effective date will be the date the Commission enters an Order approving or amending the terms of the Agreement.

**I. JURISDICTION**

1. Pursuant to K.S.A. 2018 Supp. 66-1,108b, 66-1,111, 66-1,112, 66-1,114, 66-1,114b and 66-1,115, and amendments thereto, the Commission is given full power, authority and jurisdiction to supervise and control motor carriers, as defined in K.S.A. 2017 Supp. 66-1,108, doing business or procuring business in Kansas, and is empowered to do all things necessary and convenient for the exercise of such power, authority and jurisdiction.

2. Pursuant to K.S.A. 2018 Supp. 66-1,129a, 66-1,130 and 66-1,142b, and amendments thereto, the Commission may suspend operations, revoke or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision or regulation of the Commission.

3. The Commission has the authority, pursuant to K.A.R. 82-1-237, to investigate a party under its jurisdiction.

4. Pursuant to K.S.A. 2018 Supp. 74-2108, the Kansas Highway Patrol may require the driver of any motor vehicle operated by any motor carrier to stop and submit to an inspection to determine compliance with the laws, rules and regulations relating to motor carriers. Additionally, K.A.R. 82-4-2a gives the Kansas Highway Patrol the authority to examine motor carrier equipment operating on the highways in Kansas, and examine the manner of the motor carrier's conduct as it relates to the public safety and the operation of commercial motor vehicles in Kansas.

5. Pursuant to K.S.A. 2018 Supp. 66-1,129(a), sanctions imposed against motor carriers must be done in accordance with the Kansas Administrative Procedure Act.

6. Pursuant to K.S.A. 2018 Supp. 77-505, nothing in the Kansas Administrative Procedure Act shall preclude the informal settlement of matters that may make other proceedings unnecessary.

7. Pursuant to K.S.A. 2018 Supp. 66-1,142c, a civil penalty may be compromised by the Commission. In determining the amount of the penalty or the amount agreed in compromise, the appropriateness of the penalty to the size of the business, the gravity of the violation, and the good faith of the person charged in attempting to achieve compliance shall be considered.

## **II. BACKGROUND**

8. On July 25, 2019, the Kansas Highway Patrol issued a Notice of Violation(s) against American Alliance LLC. (Respondent), for an alleged violation found during a July 23, 2019, routine motor carrier stop and inspection conducted by the Kansas Highway Patrol (KHP).

5. Pursuant to K.S.A. 2018 Supp. 66-1,129(a), sanctions imposed against motor carriers must be done in accordance with the Kansas Administrative Procedure Act.

6. Pursuant to K.S.A. 2018 Supp. 77-505, nothing in the Kansas Administrative Procedure Act shall preclude the informal settlement of matters that may make other proceedings unnecessary.

7. Pursuant to K.S.A. 2018 Supp. 66-1,142c, a civil penalty may be compromised by the Commission. In determining the amount of the penalty or the amount agreed in compromise, the appropriateness of the penalty to the size of the business, the gravity of the violation, and the good faith of the person charged in attempting to achieve compliance shall be considered.

## **II. BACKGROUND**

8. On July 25, 2019, the Kansas Highway Patrol issued a Notice of Violation(s) against American Alliance LLC. (Respondent), for an alleged violation found during a July 23, 2019, routine motor carrier stop and inspection conducted by the Kansas Highway Patrol (KHP).

9. As a result of this inspection, Respondent was assessed \$900 in civil fines, comprised of the following violations: a \$300.00 fine for Failure to register and pay UCR fees, citing 392.2UCR; a \$150.00 fine for No/improper heavy vehicle/machine securement, citing 393.130; a \$150.00 fine for No/improper breakaway or emergency braking, citing 393.43; a \$150.00 fine for Inoperative turn signal, citing 393.9TS; a \$150.00 fine for Operating a CMV with improper CDL group, citing 383.91A.

10. On August 20, 2019, Hooshang Pour, Owner & General Manager of American Alliance LLC and Mike Hoeme, Transportation Director of Staff, informally discussed the possibility of a settlement. During this and subsequent informal discussions, Staff and Respondent were able to reach mutually agreeable terms in anticipated settlement of the issues. It was agreed that Staff would subsequently reduce the terms to writing and forward the draft to Respondent for approval and signature.

### **III. TERMS OF THE STIPULATED SETTLEMENT AGREEMENT**

11. The parties agree that the Commission has jurisdiction and authority over this matter.

12. The parties also agree that adoption of this Agreement is in the public interest and that the Commission should approve the stipulations as set forth below.

13. Respondent agrees to operate commercial motor vehicles subject to the Commission's jurisdiction in a safe manner.

14. Staff agrees to recommend to the Commission that this Agreement be approved. Staff further agrees that upon approval by the Commission this Agreement shall constitute a final resolution of this matter.

15. Pursuant to K.S.A. 77-504, the Respondent waives all rights to a hearing on, or appeal of the Invoice, and withdraws its request for a hearing previously filed herein.

16. Pursuant to K.S.A. 77-526, the Commission expressly reserves and maintains the right and authority to enforce the terms of this Agreement.

17. Pursuant to the Kansas Judicial Review Act, K.S.A 77-601 *et seq.*, Respondent waives all rights to a hearing on, or appeal of, this Agreement.

#### **IV. MODIFICATION OF EXAMINATION AND INVOICE**

18. Staff agrees to dismiss the following violations: the \$300.00 fine for Failure to register and pay UCR fees, citing 392.2UCR; the \$150.00 fine for No/improper breakaway or emergency braking, citing 393.43; and the \$150.00 fine for Inoperative turn signal, citing 393.9TS. All three are identified in the Commission's Notice of Violation and Invoice No. H000581624.

19. Staff's Recommendation for dismissal of this civil assessment is based upon the specific circumstances involved in this situation as well as the Respondent's efforts to remediate the situation and attempts to ensure compliance.

20. Respondent, therefore, agrees to pay the remaining fines totaling \$300. Payments shall be made payable to the Kansas Corporation Commission and mailed to the Kansas Corporation Commission, Legal Division, 1500 S.W. Arrowhead Road, Topeka, Kansas, 66604-4027. The check should include the Docket No. 20-GIMM-089-KHP so that payment may be correctly applied.



## **V. DUTIES OF THE RESPONDENT**

21. Respondent shall, when applicable, comply with Kansas law governing the regulation of motor carriers, the Kansas Administrative Regulations and provisions of the Federal Motor Carrier Safety Regulations, as adopted by the Kansas Administrative Regulations.

## **VI. RESERVATIONS**

22. This Agreement fully resolves issues specifically addressed between the parties. The terms of this Agreement constitute a fair and reasonable resolution of the issues addressed herein.

23. The terms and provisions of this Agreement have resulted from negotiations between the signatories and are interdependent. In the event the Commission does not approve the terms of the Agreement in total, any party has the option to terminate this Agreement and, if so terminated, none of the signatories hereto shall be bound by, prejudiced, or in any way affected by any of the terms or provisions hereof, unless otherwise provided herein.

24. Unless (and only to the extent) otherwise specified in this Agreement, the signatories to this Agreement shall not be prejudiced, bound by, or affected in any way by the terms of this Agreement: (1) in any future Commission or court proceeding; (2) in any proceeding currently pending before the Commission under a separate docket; and/or (3) in this proceeding, if the Commission decides not to approve this Agreement in total or in any way conditions its approval of the same. This paragraph is not meant to limit future enforcement of this Agreement, should either party fail to fulfill all terms and provisions.

25. Unless (and only to the extent) otherwise specified in this Agreement, this Agreement does not prejudice or waive any party's legal rights, positions, claims, assertions or arguments in any proceedings in this docket, or any other proceeding before the Commission or

in any court. If the Commission approves this Agreement in its entirety and incorporates the same into a Final Order in this docket, the parties agree to be bound by its terms and the Commission's Order incorporating its terms as to all issues addressed herein, and will not appeal the Commission's Order.

26. This Agreement shall be binding on all parties upon signing.
