Dear Ms. Retz:

On July 14, 2022, the Kansas Corporation Commission (KCC or Commission) issued an Order adopting Vantage Point Solutions' (VPS) Audit Report and directed Fusion Connect, LLC (Fusion or Company) to: (1) file an Audit True-up for Fiscal Year (FY) 24 to show actual revenue and the correct assessments to be used for KUSF reporting; and (2) remit an additional \$319.80 to the KUSF. These actions were to be taken within 30 days from the issuance of the Order, or August 13, 2022.

On August 12, 2022, Fusion filed an Audit True-up for FY 24 to correct its reporting to the KUSF. On August 15, 2022, the Company remitted \$319.80 to the KUSF.

Fusion has complied with the July 14, 2022, Order.

VPS recommends that the Commission determine Fusion is in compliance with the Commission's Order and that Docket No. 22-NBSC-025-KSF be closed.


