PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE

- 1. On October 3, 2019, the Commission issued a *Penalty Order* against Castle Resources, Inc. (Operator) for one violation of K.A.R. 82-3-107 and K.A.R. 82-3-130 because Operator did not timely submit a complete and accurate well completion report, with associated documents, for the Steinhsouer Hill Farms #1 well.¹ On October 17, 2019, Operator requested a hearing.² A prehearing conference was held November 13, 2019.
- 2. At the prehearing conference, Operator and Commission Staff agreed to set a status conference for December 4, 2019, to allow for discussion of the possibility of resolution of this matter absent the need for a procedural schedule.
