**ORDER GRANTING JOINT MOTION FOR WAIVER OF CERTAIN AUDIT
REQUIREMENTS AND FOR EXTENSION OF FILING DATE**

NOW, the above-captioned matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

1. On March 24, 2015, Twin Valley Telephone, Inc. ("Twin Valley" or "the company") and Commission Staff ("Staff") filed a Joint Motion to waive certain audit requirements and grant an extension to Twin Valley to file its audited financial data in the docket.

2. The Joint Motion indicated that "Staff and the company have conferred at length regarding the elements of an audit pursuant to K.A.R. 82-1-231 that appear unnecessary for Twin Valley to file in order for Staff to investigate fully the necessary issues of Twin Valley's embedded costs, investments and revenues." Additionally, the Joint Motion indicated that omission of certain filing requirements did not constitute a waiver of either party's right to address the information should it become relevant at a later date.

3. The Joint Motion requested an extension until April 14, 2015, for Twin Valley's filing. The Joint Motion indicated that this extension was requested so that Twin Valley could file its audited financial statements without having to update them at a later date as contemplated by the original filing schedule. The Joint Motion stated that this extension "would permit the company to avoid multiple filings at additional cost."

4. Having reviewed the Joint Motion, the Commission finds that granting the Joint Motion would be in the public interest.


IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. Twin Valley and Staff's Joint Motion filed March 24, 2015, is granted.
- B. Twin Valley shall file the information required by K.A.R. 82-1-231 by April 14, 2015, with the omissions indicated in the March 24, 2015, Joint Motion.
- C. The parties have fifteen (15) days, plus three (3) days if service of this order is by mail, from the date this order was served in which to petition the Commission for reconsideration of any issue or issues decided herein. K.S.A. 66-118b; K.S.A. 77-529(a)(1).
- D. The Commission retains jurisdiction over the subject matter and parties for the purpose of issuing such further order, or orders, as it may deem necessary.
