1	Q.	Please state your name.
2	A.	My name is Bruce Mueller.
3	Q.	By whom are you employed and what is your business address?
4	A.	I am employed by Wheatland Electric Cooperative, Inc. ("Wheatland") as general
5		manager. My business address is P.O. Box 230, Scott City, Kansas.
6	Q.	Would you summarize your educational background?
7	A.	I hold a Bachelor of Business Administration in finance from Texas State
8		University and a Master of Business Administration in management from the
9		University of Houston-Victoria.
10	Q.	Please summarize your work experience.
11	A.	I have over 28 years of experience working in the investor-owned electric and
12		electric cooperative industries.
13	Q.	Are you also an officer of Mid-Kansas Electric Company, LLC ("Mid-
14		Kansas")?
15	Α.	Yes. I am member of the Board of Directors of Mid-Kansas. I have served in that
16		position since February 2012.
17	Q.	Do you serve on any other boards for public utilities?
18	Α.	Yes. Wheatland is a member of both Sunflower Electric Power Corporation
19		(Sunflower) and Mid-Kansas. I serve as a Director on the Sunflower Board of
20		Directors also.
21	Q.	What is the purpose of your testimony?

1	A.	The purpose of my testimony is to provide background information on Wheatland
2		and support for relief sought in the Joint Application filed by Mid-Kansas and its
3		Members ¹ , including Wheatland.
4		1. HISTORICAL INFORMATION ON WHEATLAND
5	Q.	Please provide an overview of your testimony.
6	Α.	My testimony will primarily focus on a brief overview of Wheatland.
7	Q.	Please provide a brief overview of Wheatland.
8	A.	Wheatland is an electric cooperative formed under the Kansas Electric
9		Cooperative Act. It was formed for the purpose of supplying electric energy and
10		promoting and extending the use of such energy in rural areas of western
11		Kansas. Wheatland was formed in 1948 and has been providing electric retail
12		service in the western Kansas for over 63 years.
13	Q.	Would you provide a summary of the service area and the nature of service
14		Wheatland provided before the acquisition of Aquila-WPK by Mid-Kansas?
15	A.	Prior to the acquisition, Wheatland provided retail electric service in six western
16		Kansas counties, with approximately 17,000 meters. Its service territory ran from
17		the middle of Scott County and the western one-fourth of Gray County on the
18		eastern end to the middle of Kiowa County, Colorado on the western end.
19		Wheatland also served various cities within its certificated territory. Although it

1		did not operate generation or transmission lines, it operated and maintained
2		approximately 3,500 miles of distribution line and 600 miles of 115 kV, 69 kV and
3		34.5 kV lines.
4	Q.	Would you provide a summary of the area served and scope by Wheatland
5		after the acquisition of the Aquila-WPK by Mid-Kansas?
6	A.	After the acquisition, pursuant to a service contract with Mid-Kansas, Wheatland
7		increased the number of meters by approximately 16,000 and continues to serve
8		approximately that number of meters in the Wheatland division. Through the
9		acquisition, the service territory was extended easterly to approximately Great
10		Bend from the eastern edge of the original Wheatland service territory. With the
11		acquisition of Aquila-WPK, the number of customers served is approximately
12		36,000.
13	Q.	Prior to the acquisition, was Wheatland a deregulated cooperative?
14	A.	No. However, Wheatland's board of directors is contemplating putting the matter
15		to a vote with its membership.
16	Q.	Why did the six Members of Mid-Kansas elect to pursue the acquisition of
17		Aquila-WPK?
18	A.	Wheatland, like the other Members, saw the acquisition as an opportunity to
19		increase its service territory and serve more residential customers. Aquila-WPK's
20		service territory was located in the general vicinity of Wheatland's service
21		territory. The expansion into this territory could be done at a far less of a cost to
22		Wheatland than any other utility as we were already serving in the general area.
23		It increased the number of customers per mile for distribution lines and allowed

1		Wheatland to spread the general overhead costs across a larger number of
2		customers. There were a number of synergies associated with the acquisition, all
3		of which resulted in cost savings to both Wheatland's existing customers and
4		those customers acquired in the acquisition.
5	Q.	Do you believe the synergies that you anticipated have been realized?
6	A.	Yes. We firmly believe the acquisition has been good for both the existing and
7		acquired customers. There have been cost savings as anticipated, and the
8		increases in costs have been slowed as a result of the synergies and ability to
9		spread costs across a larger segment of customers. Also, the diversity in
10		customers has been beneficial as economic conditions change throughout
11		western Kansas.
12	Q.	Do you believe Wheatland is capable of succeeding to a portion of Mid-
