Please find attached for your files, a report of the lost and unaccounted-for gas sub-categorized by community with over 10,000 customers. This report is submitted pursuant to the Commission's Order in Docket No. 15-GIMG-343-GIG.

Kansas Gas Service serves customers in two rate areas, denoted as the K System and the T System. T System customers are served from a transmission line owned and operated by Kansas Gas Service. Communities served in the T System do not have the metering necessary to separate out the deliveries into the community from the receipts to the specific customers and as such, those communities cannot be subdivided. For purposes of this report, Kansas Gas Service has included the total T System lost and unaccounted-for gas calculation.
