

You, and each of you, are hereby notified that Eastern Kansas Operating, LLC will file an application to request vacuum operations on the Sameday Well #14-12 located in the SE/SE/SW of Section 12, Township 16, Range 24, in Miami County, Kansas, and the Sameday Well #21-12 located in the SW/5E/SW of Section 12, Township 16, Range 24, in Miami County, Kansas. These wells operated by Eastern Kansas Operating, LLC produce natural gas from the Pleasanton and Marmaton group formations. The vacuum operations will commence immediately pending the approval of the KCC and will continue immediately.

Any persons who object to or protest this application shall be required to file their objections or protests with the Conservation Division of this State Corporation Commission of the State of Kansas within fifteen (15) days from the date of this publication. These protests shall be filed pursuant to Commission regulations and must state specific reasons why the grant of the application would be detrimental to natural resources in the State of Kansas.
