Attached for filing with the Commission are proposed changes to the Columbus Communications Services, LLC General Exchange Tariff.

The enclosed filing is being made to facilitate the scheduled removal of obsolete Section 4 Bundle Services in their entirety and replacement with new Bundle Services. The new bundled offerings reflect this year's Revised Residence Access Line Rate of \$17.00, significant increases in broadband Internet speeds, necessary changes in video service tiers resulting from increased content costs, and a realignment in toll usage packages.

The cooperative wishes to remove the existing bundles, which have become unprofitable to offer as a result of increased wholesale video content costs. The cooperative intends to offer its members a migration path to the new bundles, through June 15, 2015.

The cooperative requests an effective date of April15, 2015 for this filing.
