**WITHDRAWAL OF MOTION TO SUSPEND INTRASTATE
MOTOR CARRIER OPERATIONS**

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files a withdrawal of its motion to suspend Copperpoint - Kansas City LLC d/b/a Dick Ray Master Plumber Heating and Cooling of Overland Park, Kansas (Carrier) from intrastate commercial motor carrier operations. In support of its Withdrawal, Staff states as follows:

1. On February 8, 2024, the Commission issued Carrier a Penalty Order that assessed a civil penalty of \$1,400 for failure to pay the Unified Carrier Registration (UCR) fees for 2023 and 2024 in this docket.
2. Carrier was sent a collection letter on March 26, 2024, reminding it of the amount due and giving it 10 days from the date of the collection letter to pay.
3. As of April 16, 2024, Commission records indicate that Carrier had not complied with the collection letter or the requirements of the Penalty Order.
4. On April 24 2024, Staff filed its Motion to Suspend Intrastate Motor Carrier Operations.

5. On April 24, 2024, Carrier contacted Staff regarding its UCR fees. Staff educated the Carrier regarding UCR fees. The Carrier paid its UCR fees and provided proof to Staff. As a result, Staff determined the Penalty Order should be vacated. Staff will file a Motion to Vacate the Penalty Order.

6. Carrier's actions obviate the need to suspend the Carrier's intrastate motor carrier operations. Therefore Staff withdraws its motion.

WHEREFORE, for the reasons stated above, Staff respectfully withdraws its Motion to Suspend Intrastate Motor Carrier Operations.
