("Cricket"), pursuant to the Kansas Corporation Commission's ("Commission") Order Accepting Proposal of Cricket Communications, Inc. and Closing Docket, issued October 2, 2014 in the above captioned proceeding and submits this compliance filing. In support of its compliance filing, Cricket shows the Commission as follows:

1. On October 2, 2014, the Commission issued its Order Accepting Proposal of Cricket Communications, Inc. and Closing Docket in the above captioned Kansas Universal Service Fund audit proceeding. The Order directed Cricket to make a compliance filing "[u]pon migration of Cricket's customers to the company's new billing system..." Order at Ordering Paragraph A.

2. Attached hereto, incorporated herein and made a part hereof by this reference, is the Affidavit of Mary E. Mox, Senior Project Manager, Cricket. Ms. Mox has verified the migration status of the Cricket Kansas customers at issue in the instant proceeding, as is reflected on the spreadsheet attached to her affidavit. Ms. Mox has verified that, as of September 2015, all Cricket Kansas customers at issue were either migrated to the new billing system of Cricket or they disconnected from Cricket's network.

WHEREFORE, Cricket respectfully requests an Order of the Commission accepting Cricket's compliance filing and finding Cricket in compliance with the Order.

4. I have reviewed Cricket's records and can verify that the migration of Cricket's Kansas customers to the company's new billing system was completed in September, 2015. Attached hereto and incorporated herein as part of my affidavit is a spreadsheet I prepared documenting the month of migration, the number of customers migrated, the number of customers disconnected from Cricket's CDMA network, the total CDMA disconnection quantity, and the total number of Cricket customers remaining for migration. The spreadsheet reflects that Cricket is unable to account for one (1) customer record; however, because both the CDMA network and the billing system at issue have been discontinued,

that consumer was either migrated to Cricket's new network and billing system, or disconnected and is no longer a Cricket consumer.

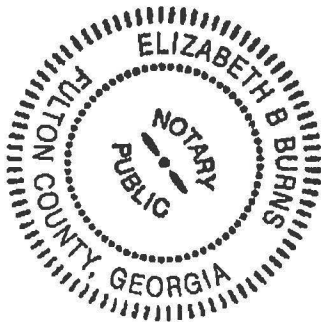


