Commission Staff (Staff) of the State Corporation Commission of the State of Kansas (Commission) files this Response, stating as follows:

- 1. On October 12, 2017, the Commission issued a Penalty Order against Operator, assessing \$10,100 in penalties for Operator's violations of K.A.R. 82-3-104 and K.A.R. 82-3-111 and requiring Operator to take certain actions to remedy the violations.
- 2. On November 14, 2017, Operator filed a document entitled "Request for Hearing," in which Operator both requests a hearing on the Penalty Order and requests that the Penalty Order be rescinded.
- 3. Staff is opposed to rescission of the Penalty Order. Operator's letter clearly demonstrates the existence of contested issues of fact.
- 4. Under K.S.A. 55-164, K.S.A. 77-537, and K.S.A. 77-542, Operator may request a hearing, and that is what should be provided.


