MOTION TO RESTRICT PROTESTANT'S RIGHT TO TESTIFY AND PRESENT EVIDENCE

For the following reasons, Commission Staff moves to restrict Lastacia Ross's (Protestant) right to testify and present evidence at the hearing scheduled for May 18, 2017.

- 1. On March 9, 2017, the Prehearing Officer issued an Order Setting Procedural Schedule, setting a May 5, 2017, deadline for submission of Protestant's pre-filed direct testimony. Protestant failed to submit any testimony.
- 2. The Prehearing Officer's March 9, 2017, Order states that failure to submit prefiled testimony may result in the Commission restricting the right to testify and present evidence at hearing. Allowing Protestant to testify and present evidence at hearing, despite Protestant's failure to timely utilize pre-filed testimony, and the clear language in the Prehearing Officer's Order regarding the possible consequences, would be both detrimental to judicial economy and prejudicial to Staff.
- 3. Therefore, pursuant to the Prehearing Officer's March 9, 2017, Order, Staff requests that Protestant not be allowed to testify or present evidence at the hearing currently scheduled for May 18, 2017.
