PRESIDING OFFICER ORDER DENYING MOTION FOR PROPOSED DEFAULT ORDER AND GRANTING MOTION TO RESCHEDULE PREHEARING CONFERENCE

On March 16, 2021, the Commission issued a Penalty Order in this matter. On April 16th Operator requested a hearing. On April 27th the Commission set a May 13th prehearing conference and directed Operator to attend via licensed attorney. Operator failed to attend the prehearing conference. On May 17th Commission Staff motioned for a proposed default order due to Operator's non-attendance. On May 19th counsel entered an appearance on behalf of Operator, and on May 21st Operator motioned to reschedule the prehearing conference.

In its motion, Operator states its counsel, although retained, had not yet discovered the order setting the prehearing conference at the time the conference occurred. Operator states it has conferred with Staff, and Staff is in agreement with the request to reschedule and has agreed to withdraw its request for a default order. While Staff has not yet withdrawn its motion, the law generally disfavors default, and based upon Operator's representation of Staff's position, the Presiding Officer finds rescheduling this matter to coincide with the procedural track of Docket 21-3201 to be appropriate.

Accordingly, Staff's motion for a proposed default order is denied, and Operator's motion to reschedule the prehearing conference is granted. A prehearing conference is scheduled for **Thursday**,
