

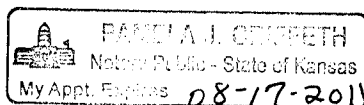

SUBJECT: In the Matter of the Application of Southwestern Bell Telephone Company for Approval of Interconnection Agreement Under the Telecommunications Act of 1996 With One Point Technologies, Inc.

BACKGROUND:

On November 14, 2008, Southwestern Bell Telephone Co. d/b/a AT&T Kansas filed an Interconnection Agreement between One Point Technologies, Inc. (One Point) and themselves.

One Point was granted authority to operate as a Competitive Local Exchange Carrier (CLEC) on February 6, 2007, in Docket No. 07-OPTT-594-COC and authorized to provide service in areas served by Southwestern Bell and Embarq.

Southwestern Bell Telephone Co. is an Incumbent Local Exchange Carrier operating in the larger metropolitan cities and rural communities throughout the state.

At the time of this filing (a/o 11-18-2008), both parties are properly registered with the Kansas Secretary of State's office and are 'active and in good standing' with the Secretary's office. Both parties are current with their KUSF assessments, KCC fees and Annual Reporting requirements.

Commission action in this matter is required not later than **Thursday, February 12, 2009.**

ANALYSIS:

The parties present this Agreement as an integrated package, the result of negotiations and compromise. The parties state that there are no outstanding issues in need of mediation or arbitration.

Section 252(e) of the Federal Act states that state commissions may reject a negotiated agreement only if it finds that the agreement (or portions thereof) discriminates against a telecommunications carrier not a party to the agreement; or the implementation of such an agreement (or portions thereof) is not consistent with the public interest, convenience and necessity. Staff has reviewed this proposed Agreement and finds no such cause for concern with this filing.

RECOMMENDATION:

Staff recommends commission approval.


