**PREHEARING OFFICER ORDER SETTING STATUS CONFERENCE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

1. On November 7, 2019, the Commission issued a *Penalty Order* against Oil Producers Inc. of Kansas (Operator) for one violation of K.A.R. 82-3-407 because a current and successful mechanical integrity test had not been performed on the Fitzgerald #3 well.<sup>1</sup> On December 10, 2019, Operator requested a hearing.<sup>2</sup> An evidentiary hearing is scheduled for February 20, 2020.<sup>3</sup>

2. The Prehearing Officer finds it appropriate to set a status conference in this docket, to discuss all issues that may assist in conducting an efficient evidentiary hearing, including order of witness presentation and identification of any likely preliminary matters or evidentiary concerns.

**THEREFORE, THE PREHEARING OFFICER ORDERS:**
