AMENDED ORDER SETTING PROCEDURAL SCHEDULE

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings and conclusions:

1. On December 19, 2019, the Commission issued its Order Setting Procedural Schedule in this docket. In that Order, the Commission noted that a public hearing would be held on Monday, January 6, 2020, beginning at 6:00 p.m. at the Liberal High School Auditorium in Liberal, Kansas. Additionally, the Commission Order noted a video conference of the public hearing would be held at the same time and same day at Medicine Lodge High School in Medicine Lodge, Kansas. After review, the Commission has determined the information in the Order should clarify that a public hearing will be held at both Liberal High School and Medicine Lodge High School Library. Both will be conducted on **January 6, 2020, at 6:00 p.m.** The addresses for the public hearing locations are as follows:

- 2. Commissioners and Commission Staff will be present at both locations.

However, this should read that the "Commission and Southern Pioneer have agreed that Southern Pioneer will run ads pertaining to the proceeding only in those newspapers in Liberal and Medicine Lodge since those are the hearing sites." A. Public Hearing, Notice and Comment Period

5. The Commission adopts the recommendation of the Parties and PACP that one public hearing be conducted in this docket as follows:

The hearing will be recorded and posted on the Commission's website at www.kcc.ks.gov for those unable to attend. Commissioners and Commission Staff will be present at both locations.

6. The Commission and Southern Pioneer have agreed that Southern Pioneer will run ads pertaining to the proceeding only in those newspapers in Liberal and Medicine Lodge, since those are the hearing sites. The newspaper ads will be in addition to the bill inserts and/or electronic mail that Southern Pioneer will use to notify customers in all locations. The Commission orders and directs that notice by published in newspapers approved by the Director of PACP, and that Southern Pioneer work with the Director of PACP to determine the timing of publication.

THEREFORE, THE COMMISSION ORDERS:

- A. A public hearing shall be held on January 6, 2020, beginning at 6:00 p.m., at both Liberal High School Auditorium, 1611 W 2nd Street, Liberal, Kansas 67901 and the Medicine Lodge High School Library, 400 W Eldorado Avenue, Medicine Lodge, Kansas 67104.
- B. Southern Pioneer is directed to provide the notice to its customers of the public hearings and Application through a bill insert included with the monthly billing statement for each customer in its service territory, or by electronic mail to those customers who receive their bill by electronic mail.
- C. Southern Pioneer is directed to publish notice in the newspapers of both Liberal, Kansas, and Medicine Lodge, Kansas, and work with the Director of Public Affairs and Consumer Protection to determine the timing in which notice will be published.
- D. This Order will be served by electronic mail, with a note that no hard copy of this Order will follow. This Order is a procedural order and constitutes non-final agency action.⁴
- E. Parties have 15 days from the date of electronic service of this Order in which to petition the Commission for reconsideration.⁵
