**PRESIDING OFFICER ORDER REGARDING ELECTRONIC SERVICE**

At a July 14, 2022, prehearing conference, all parties consented to the electronic service of all documents<sup>1</sup> and orders.<sup>2</sup> Accordingly, the Presiding Officer rules as follows:

1. Service of all documents and orders may be made by email. To the extent practicable, any electronically served document or order shall be attached to the email and served in pdf format. Service of orders is complete upon transmission.<sup>3</sup> Parties are encouraged to make sure large pdf files do not result in delivery failure and to work together to resolve any email-based service issues.
