You, and each of you, are hereby notified  
that Quail Oil & Gas, LLC has filed an Application,  
pursuant to K.A.R. 82-3-401, seeking a permit  
to authorize the injection of saltwater into the  
applicant's Sly 2-6 SWD well, located in the NE 1/4  
NE 1/4 SE of Section 6, Township 17 South,  
Range 6 East, in Morris County, Kansas.

Pursuant to K.A.R. 82-3-135a(e), the above-  
referenced matter has been set for hearing. The  
hearing will be held on June 15, 2017, at 10:00  
a.m., or as soon thereafter as the same may be  
reached, at the Kansas Corporation Commission,  
266 N. Main, Suite 220, Wichita, Kansas 67202.

The hearing will be formal in nature and will  
involve both the rules of civil procedure and the  
rules of evidence. Please note that K.A.R. 82-  
1-228(d)(2) requires that corporations appear  
through an attorney. Pursuant to K.A.R. 82-1-  
229, Applicant must prefile direct testimony by  
April 24, 2017, any protestant must prefile direct  
testimony by May 8, 2017, and Commission Staff  
must prefile direct testimony by May 22, 2017.  
Applicant must prefile rebuttal testimony by June  
5, 2017. One original and seven copies (or two  
copies if filed by mail or hand delivery, pursuant to  
the Prehearing Officer Order Allowing Electronic  
Service) of prefilled testimony must be filed with  
the Executive Director of the Commission, 266 N.  
Main, Suite 220, Wichita, Kansas 67202. Rebuttal  
testimony may be presented at the hearing.

Any person requiring special  
accommodations under The Americans With  
Disabilities Act needs to give notice to the  
Commission at least ten (10) days prior to the  
scheduled hearing date.

The Commission will preside over this
