AMENDED JOINT MOTION FOR APPROVAL OF PROCEDURAL SCHEDULE

Atmos Energy Corporation ("Atmos Energy"), the Staff of the Kansas Corporation Commission ("Staff") and the Citizens' Utility Ratepayers Board ("CURB") (collectively, the "Parties") request the Kansas Corporation Commission ("Commission") grant this amended joint motion for procedural schedule ("Amended Joint Motion"). This amendment is made to correct the dates of the Deadline for Petitions to Intervene and the Public Hearing in the proposed procedural schedule which were transposed in the Joint Motion filed August 15, 2025. In support of the Amended Joint Motion, the Parties state as follows:

1. On July 25, 2025 Atmos Energy filed an Application with the Commission to make certain changes in its rates and charges for natural gas service which was docketed in the above captioned proceeding.
2. On July 25, 2025 CURB filed its Petition to Intervene and Motion for Protective Order, Discovery Order and Order Assessing Costs.
3. The Commission issued its Order Assessing Costs and its Suspension Order in the above captioned matter on July 31, 2025.
4. On July 31, 2025 the Commission granted CURB's Petition to Intervene.
5. The Parties have discussed a proposed procedural schedule in this docket and were able to reach agreement on a schedule that could be recommended to the Commission for its review and

approval.

6. The Parties' proposed procedural schedule is as follows:



7. Atmos Energy has agreed to extend the 240-day deadline by one day to accommodate

the proposed schedule.

8. The Parties have further agreed to the use of electronic service for pleadings, data requests and Orders and waive receipt of a follow-up hard copy.

WHEREFORE, the Parties respectfully request the Commission grant this Amended Joint Motion for Procedural Schedule; issue an order adopting the proposed procedural schedule; and approve the use of electronic service for pleadings, data requests and Orders.




