This parcel was annexed by the City of Wellington via Ordinance No. 4217 on 11-21-17. Sumner Cowley Electric applied for a franchise with the City of Wellington to continue serving this certified territory. This request was denied by the city council per staff recommendation/council vote on 3-20-18.

SB 323 was approved by the Governor of the State of Kansas 3-5-18 and will apply to this parcel of ground.

The bill adds to such compensation amount equal to 8.5 percent of the gross revenues of total retail sales attributable to the new customers in the territory in which service rights have been terminated for a period of ten years following the date of termination of service rights of the retail electric supplier.
