



Particulars of the hearing:

To: Jose Guererro, father of the above named child(ren), and any paternal relatives and any other interested parties and all other persons who are or may be concerned:

You are hereby notified that a petition has been filed in this Court alleging that you are a Child Custody Defendant. The Court finds that the parents are not in a position to care for or take a decision which renders the parents unable to care properly for a child, the conduct or condition it is unlikely to change in the foreseeable future, the parental right of the parties will not be terminated, and permanent custody should be awarded to the child.

A hearing on the petition is scheduled at 1:00 PM on the 18th day of April, 2022, at the Finney County District Courthouse, Hutchinson, Kansas, Garden City, Kansas. At the hearing, the Court may issue orders relating to the custody, visitation, and other rights of the child. The Court will determine what rights the child should have, the person with whom the child should be deprived of their parental rights and the right to custody of the child.

In hearing on the petition, all other persons having legal custody are required to appear before this Court on the date and time shown, or to file a written response to the petition with the Clerk of the District Court prior to its filing. Failure to respond as to appear before the Court at the time shown will be deemed by the Court as failing to appear and the Court may enter a default judgment in favor of the child. In State v. Care, removing the child from the custody of parent, parent or any other person legal guardian and further order of the Court, or finding the parents unfit, and entering an order permanently terminating the parental rights of the parents.

An Attorney has been appointed as guardian ad litem for the child, Luis Blake Ross. You have the right to appear before the Court and be heard personally, either with or without an attorney. The Court will appoint an attorney if you are unable to hire one or if you are unable to afford one. The Court may order one or both parents to pay child support.






