

WHEREFORE, CURB respectfully requests inclusion of said counsel on record and to receive any future documents in this matter.



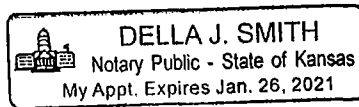
