This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On September 1, 2016, Commission Conservation Staff (Staff) issued a Notice of Denial of License Renewal Application. Staff stated the Operator's license was denied on the basis of Staff's assertion that the Operator's Application did not meet the requirements of K.S.A. 55-155.
 - 2. On September 14, 2016, the Operator filed a request for hearing.
- 3. On June 5, 2018, Staff filed a Motion to Close Docket, noting that "Staff and Operator settled this matter under terms that resolved all compliance issues . . . and provided for renewal of Operator's license." Staff further stated that it "has processed Operator's [license] application" and "there are no remaining issues to be resolved."
