#### ORDER NUNC PRO TUNC

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record and being fully advised in the premises, the Commission finds and concludes as follows:

- 1. On April 30, 2019, the Commission issued an Order to Global Connection Inc. of America (Global) in this Docket to permit it to relinquish its authority to conduct business as an Interexchange Carrier (IXC) on or after May 11, 2019. The Order incorrectly referenced the date the Global IXC authority would be cancelled. The date should have been May 11, 2019 rather than the effective date of the Order.
- 2. Accordingly, the Commission finds that the Order dated April 30, 2019 should be corrected to reflect May 11, 2019 as the date on which the Global IXC authority is to be cancelled.

### IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. To correct paragraph A of the Order dated April 30, 2019, the cancellation of the IXC authority granted to Global Connection Inc. of America in Docket No. 04-GCAT-1166-COC is changed to May 11, 2019.

B. The Commission retains jurisdiction over Global Connection Inc. of America and the subject matter of this Docket for the purpose of issuing such additional orders as it may deem necessary.
