**COMPLIANCE FILING OF
ANADARKO NATURAL GAS COMPANY, LLC**

Pursuant to paragraph 6.b of the Stipulated Settlement Agreement between Anadarko Natural Gas Company, LLC ("ANGC"), Anadarko Energy Services Company ("AESC"), and the Staff ("Staff") of the State Corporation Commission of the State of Kansas ("Commission" or "KCC"), approved by the KCC in Docket No. 14-ANGG-119-COM, ANGC hereby files all currently effective ANGC customer specific contracts for the sale and/or transportation of natural gas on ANGC's Hugoton Residue Delivery System ("HRDS"). In support of this filing, ANGC states as follows:

I. PARTY

1. ANGC is a corporation organized and existing under the laws of the State of Delaware, and is authorized to do business within the state of Kansas. ANGC's principal offices are located in Houston, Texas, and it maintains an office in Liberal, Kansas. ANGC owns and operates a pipeline system located west of the city of Hugoton, Kansas in Morton and Stevens Counties, known as the HRDS. Natural gas is supplied to the HRDS via an interconnection with Kansas Gas Service pipeline facilities. The HRDS is not regulated as a public utility pipeline by the KCC. Per the Stipulated Settlement Agreement filed in Docket No. 14-ANGG-119-COM, ANGC is required to file all natural gas sales contracts pertaining to service on ANGC's HRDS with the Commission.

II. FACTUAL BACKGROUND

4. On January 15, 2014, ANGC, AESC, and Staff filed a Stipulated Settlement Agreement in KCC Docket No. 14-ANGG-119-COM.¹ The Stipulated Settlement Agreement resolved all issues raised in Docket No. 14-ANGG-119-COM between Staff, ANGC, and AESC. Paragraph 6.b of the Stipulated Settlement Agreement requires ANGC to file “all currently effective ANGC customer specific contracts for the sale and/or transportation of natural gas on the HRDS” for approval by the Commission.

5. On January 15, 2015, the Commission issued an Order Granting ANGC’s Motion to Dismiss Complaint with Prejudice and Granting Joint Motion for Approval of Stipulated Settlement Agreement.²

6. SWKI-Seward West Central, Inc. and SWKI-Stevens Southeast, Inc. (collectively, the “NPU’s”) filed a Petition for Reconsideration of the Commission’s January 15, 2015 Order on January 30, 2015.³

7. On February 26, 2015, the Commission issued its Order Denying SWKI-Seward West Central, Inc. and SWKI-Stevens Southeast, Inc. Petition for Reconsideration.⁴


III. ACCEPTANCE AND APPROVAL OF ANGC GAS SALES CONTRACTS

8. In compliance with paragraph 6.b of the Stipulated Settlement Agreement approved in Docket No. 14-ANGG-119-COM, ANGC has attached the four currently effective ANGC customer specific contracts for the sale and/or transportation of natural gas on the HRDS (Attached as Confidential Exhibits A-D).

WHEREFORE, ANGC respectfully requests the Commission accept and approve the attached customer specific contracts filed by ANGC in compliance with paragraph 6.b of the Stipulated Settlement Agreement approved in KCC Docket No. 14-ANGG-119-COM.



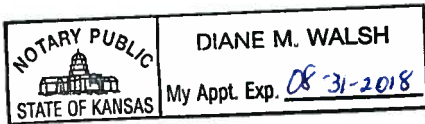
