



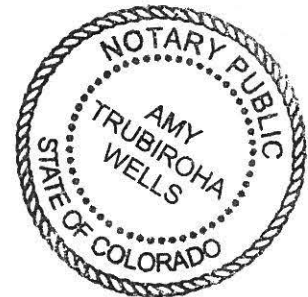

COMES NOW KC Resources, Inc., Applicant herein, and respectfully states to the Commission as follows:

1. Applicant is a corporation authorized to do business within the State of Kansas, with its correct address being P. O. Box 6749, Snowmass Village, Colorado 81615.
2. The Applicant is the owner of oil and gas leasehold interests and operates wells in Kingman County, Kansas.
3. The Applicant desires to drill the Miles A-9 well at a location 200 feet from the north line and 338 feet from the east line in Section 30, Township 27 South, Range 10 West, Kingman County, Kansas. The acreage to be attributed to the Miles A-9 well is 40 acres surrounding the well located in the Northeast Quarter in Section 30, Township 27 South, Range 10 West, Kingman County, Kansas. Applicant requests the well be assigned a full allowable. Applicant's proposed Notice of Intent to Drill is attached hereto as Exhibit A. A plat showing the proposed location and all surrounding wells is attached hereto as Exhibit B.
4. Applicant desires to drill the Miles A-9 well at the requested location in order to avoid the Miles A-1 wellbore (P&A'd) and to gain the most advantageous geological position to assure reservoir availability at said location.
5. Applicant requests an exception pursuant to K.A.R. 82-3-108 in order to allow the drilling of this well closer than 330 feet from the nearest lease or unit boundary to avoid the P&A'd

Miles A-1 wellbore and to prevent waste without violating correlative rights.


