

3. On May 24, 2018, Black Hills, by and through counsel, James G. Flaherty, pursuant to Supreme Court Rule 116, filed a motion and affidavit in support of admission *pro hac vice* for Dari R. Dornan to appear and participate as co-counsel for Black Hills in this proceeding.

4. The Motion and affidavit stated that Dari R. Dornan would act as counsel with Mr. Flaherty and is a licensed attorney in good standing in the states of Nebraska and Louisiana. The Motion and affidavit provided that Dari R. Dornan has never been suspended, disbarred or resigned as a result of a disciplinary charge, investigation, or proceeding from the practice of law in any jurisdiction.
