**WITHDRAWAL OF MOTION TO SUSPEND INTRASTATE
MOTOR CARRIER OPERATIONS**

The Staff of the State Corporation Commission of the State of Kansas (Staff), by and through its counsel, files a withdrawal of its motion to suspend Overland Logistics Inc of Overland Park, Kansas (Carrier) from all intrastate commercial motor carrier operations and request to close docket. In support of its Withdrawal, Staff states as follows:

1. On August 31, 2023, the Commission issued Carrier a Penalty Order that assessed a civil penalty of \$300 for failure to pay the Unified Commercial Registration (UCR) fees for 2023.
2. On November 8, 2023, Staff filed its Motion to Suspend Intrastate Motor Carrier Operations.
3. On November 8, 2023, Carrier contacted Staff to confirm it had paid its 2023 UCR fees.
4. Carrier's actions obviate the need to be suspend the Carrier's intrastate motor carrier operations. Therefore Staff withdraws its motion.

WHEREFORE, for the reasons stated above, Staff respectfully withdraws its Motion to Suspend Intrastate Motor Carrier Operations.
