STATUS UPDATE GRANTING 30-DAY EXTENSION

On August 20, 2019, the Commission issued an Order Approving Compliance Agreement (Agreement) in this docket.¹ On June 8, 2023, Commission Staff filed a Motion to Approve Amended Compliance Agreement.² On June 20, 2023, the Commission issued an Order Granting Motion to Approve Amended Compliance Agreement.³ The Amended Agreement provides that Operator may request an extension of time to achieve compliance for up to 30 days from an applicable deadline established under the Agreement upon good cause shown.⁴ Staff will grant or deny such request.⁵

On July 29, 2024, Operator requested an extension of its July 31, 2024, deadline. The District #2 Supervisor believes Operator's reasons for the request demonstrated good cause for an extension. Commission Staff grants Operator's request. Under the terms of the agreement, Operator's July 31, 2024 deadline is extended to August 30, 2024.
