ORDER NUNC PRO TUNC CORRECTING ORDER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On August 11, 2025, Sunflower Electric Power Corporation ("Sunflower"), and one of its member-owners, Prairie Land Electric Cooperative, Inc., jointly filed an Application for approval of the continuation of their respective individual 34.5kV Formula-Based Rates.
- 2. On August 20, 2025, KPP Energy, A Municipal Energy Agency ("KPP") filed a Petition to Intervene in this Docket.
- 3. On September 4, 2025, the Commission issued its Order Granting Interventions; Protective and Discovery Order ("Order Granting Interventions") in this Docket. Paragraphs 3 and 6 of the September 4, 2025, Order contain typographical errors in that KPP is referred to as "Kansas Power Pool" rather than "KPP Energy, A Municipal Energy Agency."
 - a. Corrected paragraph 3 should read as follows:

"On August 20, 2025, KPP Energy, A Municipal Energy Agency, ("KPP") filed a Petition to Intervene, explaining it takes service from Prairie Land's 34.5kV facilities, and, therefore would be impacted by any changes or the potential continuation of the applicant's 34.5 kV FBR Plan."

b. Corrected paragraph 6 should read as follows:

"The Commission finds and concludes that KPP has met the requirements of K.A.R. 82-1-225 and K.S.A. 77-521(b) and should be granted intervention in this Docket. KPP will be added to the mailing list, and electronic service of pleadings, communications, and correspondence should be delivered to:
