# PROCEDURAL ORDER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

- 1. On May 4, 2016, Southern Pioneer Electric Company (So. Pioneer) filed its annual update to its wholesale demand rate for Local Access Delivery Service in accordance with the Commission approved settlement in Joint Application of Mid-Kansas Electric Company, LLC et al. for Approval of Individual 34.5kV Formula Based Rates, Docket No. 16-MKEE-023-TAR (Mar. 10, 2016) [hereinafter 16-023 Docket].
- 2. Pursuant to the Commission's Order in the 16-023 Docket, the Commission orders that the following procedural schedule shall govern the proceeding:

- 3. Pursuant to the above mentioned Commission Order, the Commission has the authority to require an evidentiary hearing on the matter of setting just and reasonable rates concerning So. Pioneer's 34.5ky Formula Based Rate Plan. The Commission will preside. Any party who fails to attend or participate in the hearing (if necessary) or any other stage of the proceedings may be held in default.1
- 4. The Commission notes and accepts So. Pioneer's waiver of the 90 day deadline for approval sans hearing in the event So. Pioneer's companion docket *Annual Filing of Southern* Pioneer Electric Company for Approval to Make Certain Changes to its Charges for Electric Services, Pursuant to the Debt Service Coverage Formula Based Ratemaking Plan Approved in Docket No. 13-MKEE-452-MIS, Docket No. 16-SPEE-497-RTS (May 2, 2016) necessitates a hearing.

### THEREFORE, THE COMMISSION ORDERS:

- A. The above procedural schedule is hereby adopted.
