#### **DEFAULT JUDGMENT**

The above-captioned matter comes before the State Corporation Commission of the State of Kansas. Having examined the files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

- 1. On January 21, 2016, the Commission issued its Default Order, finding the captioned operator in default of its proceedings. No response was filed by the operator.
- 2. On February 16, 2016, Commission Staff filed a Motion for Default Judgment, requesting an order requiring the operator to plug the five subject wells known as the North Neely #1, North Neely #2, North Neely #6, NEE #02, and NEE #03, all located in Sec. 30-28S-19E, Neosho County. Staff requested the Operator's license be suspended until the subject wells are plugged, and that Staff should be directed to shut-in and seal all of the operator's continuing oil and gas operations in Kansas.

### THEREFORE, THE COMMISSION ORDERS:

- A. Multiplex Resources, Inc. is directed to plug the five subject wells.
- B. Staff is directed to suspend the operator's license until such time as compliance with this Order is obtained.

C. Staff is directed to shut-in and seal any of the operator's continuing oil and gas operations in Kansas until such time as compliance with this Order is obtained.

D. Any party affected by this Order may file with the Commission a petition for reconsideration pursuant to K.S.A. 77-529(a). The petition shall be filed within 15 days after service of this Order. If service of this Order is by mail, three days are added to the deadline. The petition shall be addressed to the Commission and sent to 266 N. Main, Ste. 220, Wichita, Kansas 67202. Pursuant to K.S.A. 55-606 and K.S.A. 77-529(a), reconsideration is prerequisite for judicial review of this Order. Any party taking an action permitted by this summary proceeding before the deadline for a petition for reconsideration does so at their own risk of any further proceedings.

E. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders as it may deem necessary.
