JOINT MOTION FOR PROCEDURAL SCHEDULE AND LIMITED WAIVERS

COMES NOW, Southern Pioneer Electric Company (Southern Pioneer), the Staff of the State Corporation Commission (Staff and Commission, respectively), the Kansas Electric Power Cooperative, Inc., the Kansas Power Pool and Citizens' Utility Ratepayer Board (CURB) (collectively referred to as Joint Movants) and hereby move the Commission for an Order establishing a procedural schedule in the above-captioned docket. In support of its motion, Joint Movants state the following:

- 1. On April 30, 2018, Southern Pioneer filed its Application seeking approval of its fifth and final Annual Update of the Commission-approved 5-year Debt Service Coverage (DSC) Formula Based Ratemaking (FBR) Pilot Program (DSC-FBR Plan or DSC Plan), and its third and final Annual Update of the Commission-approved 3-year 34.5kV Formula Based Ratemaking Plan (34.5kV FBR Plan) to request certain changes to its retail rates and wholesale Local Access Delivery Service demand rates (LADS), respectively.¹
- 2. On May 2, 2018, CURB filed its Petition to Intervene² and the Commission issued an Order Granting CURB Intervention on May 10, 2018.³

- 3. On May 4, 2018 and May 17, 2018, respectively, William G. Riggins filed an Entry of Appearance⁴ on behalf of Kansas Electric Power Cooperative, Inc., and Amy Fellows Cline filed an Entry of Appearance⁵ on behalf of Kansas Power Pool.
- 4. Joint Movants have worked collaboratively to develop a procedural schedule for this proceeding. The proposed schedule, as agreed by Joint Movants, is as follows:


