**ORDER CLOSING DOCKET**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On June 26, 2018, the Commission issued a *Penalty Order* against Fritzler Resources, Inc. (Operator) for failure to comply with K.A.R. 82-3-111, penalizing the Operator \$100.<sup>1</sup>
2. On July 23, 2018, the Operator filed a request for hearing.
3. On July 31, 2018, the Commission issued its *Order Designating Prehearing Officer and Setting Prehearing Conference*, scheduling a Prehearing Conference for September 13, 2018.<sup>2</sup>
4. On August 7, 2018, the Operator filed a letter withdrawing its request for hearing, stating that “[t]he Siemens 1-29 has received a temporary abandonment status and we have paid the \$100 dollar fine.”<sup>3</sup>
5. In light of the Operator’s letter withdrawing its request for hearing, the Commission finds further proceedings are unnecessary, and this docket should be closed.
