The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having examined its files and record, and being duly advised in the premises, the Commission finds and concludes as follows:

On August 2, 2016, the Commission directed GVNW Consulting, Inc. (GVNW) 1. to perform an audit of Xtension Services Inc. (Xtension) for Kansas Universal Service Fund (KUSF) purposes.

2. On September 7, 2016, Xtension filed a request seeking cancellation of its Certificate of Convenience and Authority (Certificate), issued June 3, 2002, in Docket No. 02provide interexchange XSIC-698-COC. authorizing the company intrastate to telecommunications (IXC) services in the State of Kansas. In response to Xtension's request, the Commission, on October 18, 2016, issued its Order in Docket No. 17-XISC-125-CCS granting Xtension's request and cancelling the company's Certificate.

3. Inasmuch as Xtension's Certificate to provide IXC services in Kansas has been canceled, GVNW filed a letter in the above-captioned docket on October 28, 2016, recommending the Commission close this docket.

4. The Commission has reviewed GVNW's October 28, 2016, letter and concludes that it should accept and adopt GVNW's recommendation and close this docket.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

A. The Commission accepts and adopts GVNW Consulting, Inc.'s recommendation and the above-captioned docket is hereby closed.

B. The Commission retains jurisdiction over Xtension Services Inc. and the subject

matter of this Docket for the purpose of issuing such additional orders as it may deem necessary.
